- **Write for Rights 2014 Report.** (15/04/2015). Index number: ACT 30/1454/2015. This report contains full details of what happened during the Write for Rights campaign in 2014 and includes human rights impact analysis on all 12 cases featured in the campaign, details of the final global action number and information about what happened around the world.

- **Bahrain: Behind the rhetoric: Human rights abuses in Bahrain continue unabated.** (15/04/2015). Index number: MDE 11/1396/2015. Amnesty International has monitored human rights developments in Bahrain for many years but never more closely than in the past four years, which have seen widespread violations by government security forces. These have included torture and other ill-treatment of detainees, unfair trials, the imprisonment of prisoners of conscience and unlawful killings, with those responsible all too frequently escaping accountability. This report documents many of these human rights violations and recommends a series of measures that the government should take if it is committed to ending abuses and upholding the rights of all Bahrainis without discrimination.

- **Nigeria: "Nuestro trabajo es disparar, matar y masacrar": La campaña de terror de Boko Haram en el nordeste de Nigeria** (13/04/2015). Index number: AFR 44/3060/2015 (Resumen Ejecutivo) / Index number: AFR 44/1360/2015 (Informe). Desde 2009, Boko Haram ha llevado el caos y el sufrimiento a las vidas de millones de personas en el nordeste de Nigeria. Este grupo armado ha dado muerte a miles de personas, ha secuestrado al menos a 2.000 mujeres y niñas y ha obligado a más de un millón de habitantes a huir de sus hogares. Su campaña de homicidios, atentados, secuestros, saqueos e incendios casi diarios ha paralizado la vida cotidiana en la región.

- **The human rights impact of less lethal weapons and other law enforcement equipment** (12/04/2015). Index number: ACT 30/1305/2015. This paper focuses on a selection of less lethal law enforcement weapons and equipment commonly used in places of detention and in the policing of protests in the following five categories: restraints, kinetic impact devices, chemical irritants (including riot control agents), electric shock devices, and other technologies such as acoustic devices. It includes those commonly used for, or that have no other purpose than, torture or other ill-treatment.

HUMAN RIGHTS WATCH

- **Ripe for Abuse** (13/04/2015). Palestinian Child Labor in Israeli Agricultural Settlements in the West Bank. This 74-page report documents that children as young as 11 work on some settlement farms, often in high temperatures. The children carry heavy loads, are exposed to hazardous pesticides, and in some cases have to pay themselves for medical treatment for work-related injuries or illness.

- **“RECHAZOS EN FRONTERA”: ¿FRONTERA SIN DERECHOS?** (13/04/2015). El rechazo en frontera de extranjeros interceptados en la zona de intervallado o en cualquiera de las vallas es “radicalmente ilegal”. ECRE

- **Unwanted, unnoticed: an audit of 160 asylum and immigration-related deaths in Europe.** (10/04/2015). A report by the **Institute of Race Relations (IRR)** has documented the death of 160 migrants and refugees in Europe between January 2010 and December 2014. Of them, 60 asylum seekers committed suicide, hours or days before a scheduled return to their country. 26 asylum seekers died of illness with medical assistance being denied, severely delayed or inadequate. 16 died as a result of destitution either through accidents or illness caused by having to live on the streets or in derelict buildings. Nine died after direct contact with police or security officials, result of beatings, restraint or shooting. Four died during police chases or immigration raids, in accidents, or, afraid of being arrested, by throwing themselves from high storey buildings. Four (including a 10-year-old child) died in Germany, hit by trains on railway tracks they were forced to cross to get to shops from their reception centre. Two were killed by violent room- or cellmates, whose psychological problems were untreated, ignored or punished. Two people died violently in their country of origin after their deportation following refusal of asylum from Belgium and Ireland.

- **Calais: migrants forced to move to old dumping grounds with no basic infrastructures.** (10/04/2015). France terre d'asile, along with 11 other French NGOs have denounced that since Thursday 31 March, the French authorities have forced more than a thousand migrants to move from makeshift camps around Calais to a new site in the proximity of the new day centre 'Jules Ferry'.

AIDA

- **AIDA Update: Belgium cuts accommodation for asylum seekers amidst proposals for more restrictive policies on asylum.** (16/04/2015). The third update of the AIDA Belgium report expresses concern around the continuous reduction of reception places for asylum seekers in the country. Following a drop from 23,800 reception places in 2013 to 19,000 in 2014, Belgium's capacity at the beginning of 2015 fell once more to 17,400 places in addition to 1,800 places that can be made readily available in a few days in case of a sudden rise in asylum applications. By the end of the year, reception capacity is

expected to shrink even further to approximately 16,600 reception places, as a consequence of budget cuts. The report by the Belgian Refugee Council (BCHV-CBAR) highlights that this reduction in reception space is taking place against a background of increasing numbers of protection applications in the country, which rose from 15,800 in 2013 to over 17,000 in 2014. The increase in applications has been coupled by a rise in positive decisions on asylum claims reaching over 36% in 2014, an unprecedented recognition rate in Belgium.

- **AIDA Update: Cyprus continues to detain asylum seekers beyond lawful time-limits.** (09/04/2015). Asylum seekers in Cyprus are being detained for longer periods than what is prescribed by law, according to a new AIDA report on Cyprus. The Future Worlds Center reports that since the end of 2014, asylum claims of people in detention ought to be processed within 30 days, with appeals taking no more than 15 days, following the introduction of a fast-track procedure. If the applicant is granted international protection or the decision is delayed, they must therefore be released. Latest monitoring by Future Worlds Center suggests that the prescribed time-limits are not being followed by the authorities. Furthermore, Cyprus continues to detain asylum seekers for deportation purposes as soon as their protection claims have been refused at the first instance, without providing the opportunity to effectively exercise their right to appeal before the Supreme Court. Asylum seekers who are waiting for a final decision from the Supreme Court continue to risk deportation.

- **Equal protection for all victims of hate crime - The case of people with disabilities.** (Marzo 2015). This paper discusses the difficulties faced by people with disabilities who become victims of hate crime, and the different legal frameworks in place to protect such victims in the EU's Member States. It ends by listing a number of suggestions for improving the situation at both the legislative and policy levels.

- **"Make Way for Justice": universal jurisdiction in 2014 scrutinized by three NGOs** (14/04/2015). TRIAL, ECCHR and FIDH have published their first annual review of the main universal jurisdiction cases in 2014. "Make Way for Justice" examines all cases in which notable developments occurred in 2014. A total of 37 cases were studied in order to gain a better understanding of the potential of this under-exploited principle in the fight against impunity.

The report outlines the massive internal displacement caused by militant group Boko Haram not only in north-east Nigeria, ground zero of the crisis, but also by waves of attacks carried out in neighboring Cameroon, Chad and Niger. The effects of the crisis are reverberating across the wider Sahel, a region suffering chronic levels of malnutrition.

El pasado año 2014 se cerró con un total de 1.285 delitos de odio, según el informe presentado este martes por el ministro del Interior, Jorge Fernández Díaz. En este estudio se refleja que los delitos por razón de la orientación sexual de la víctima son los más repetidos (con 513 casos), seguidos de los delitos racistas (475 casos), aquellos dirigidos contra las personas con discapacidad (199), por creencias religiosas (63 casos) y actitudes antisemitas (24 casos). Finalmente hay un 0,9 de delitos de aporofobia, acciones contra mendigos.

- **Ukraine: Situation report No.35 as of 10 April 2015.** (Report from OCHA). (10/04/2015). Rapidly increasing food prices, decreased food consumption have impacted the lives of many in the eastern oblasts of the country. Access to social services such as pension and salaries remains suspended in many conflict-affected areas. Access constraints related to bureaucratic procedures and different practices in the field continue hinder response. Funding for humanitarian operations remains low: only 18 percent of the USD 316 required for 2015 has been funded or pledged.

- **South Sudan: Crisis Situation Report No.82 (as of 10 April 2015).** (Report from OCHA). (10/04/2015). Nearly 4,600 displaced people fled violence into Malakal PoC site. Aid agencies met in Addis Ababa, Ethiopia to discuss cross border operations from Ethiopia to South Sudan. A measles vaccination campaign was launched in Bentiu PoC site, reaching 8,783 children by the end of the week. The number of recorded displaced people in the Bentiu PoC sites has increased from 53,000 to about 75,000 people. Partners have so far vaccinated one million cattle, sheep and goats in the country from January to date.
